You have worked hard during your lifetime and have gathered assets along the way. Making a Will is the only guaranteed way of ensuring that your assets are distributed in accordance with your wishes so that the people or

charities you have chosen will benefit from them. Making a simple Will should cost about £100 but could be more if it is complicated.

**Leaving a gift in your Will to the Commonwealth Forestry Association could help make a difference to the future of forests throughout the world.**

## How to leave a legacy to the CFA

Leaving a legacy is not difficult and you do not necessarily need to re-write your existing Will. You can prepare a Codicil (additional text to your Will) which has to be signed, dated and witnessed in the same way as your Will. Your solicitor can advise.

As the CFA is an exempt charity, gifts are not liable for Inheritance Tax. Such a gift could thus bring the value of your taxable estate below the level at which tax is charged.

When considering leaving gifts in your Will there are a number of options:


**A pecuniary Gift:** The gift of a fixed sum of money.

**A residuary Gift:** The residue of your estate (or a percentage of it) after all other legacies, inheritance, tax, debts and expenses have been paid.

**A specific Gift:** You can bequeath specific personal possessions including property and/or shares.

**A reversionary Gift:** You can give assets to a chosen beneficiary while allowing a different named person to benefit from the assets during his/her lifetime.

Whatever you decide to give to the CFA, it will be well used.

The following paragraph is an example of the wording to send to your solicitor to prepare a Codicil (or to include in a new Will) to make a pecuniary legacy to the Commonwealth Forestry Association.

*"I give to the Commonwealth Forestry Association of The Crib, Dinchope, Craven Arms, Shropshire SY7 9JJ (Registered Charity No. CC250739) the sum of .....*

*.....pounds*

*(£.....) and I declare that the receipt of the Treasurer for the time being or other authorised officer of the said Association shall be a good discharge to my Executors in respect of such a legacy."*
